

5. There shall be no liability on the part of any party to the other arising from the termination of this MoU.

Neither party will disclose the existence, or the terms and conditions, of this MoU or any information connected with it or any information received from the other or otherwise during the implementation of this MoU or its subsequent amendments, if any, except as may be required by law or on a strictly "need-to-know" basis for the purpose of implementing this MoU, or its subsequent amendments, if any, unless express prior written consent of the other party shall have been obtained in advance.

11. Unless previously consented to by both parties, there shall be no assignment of any interest under this MoU by any party hereto.


12. The MoU is valid up to One Year from the date. After one years can be renewal the MoU as same procedure.
