Scholarship Policy



5. The Administrative Office will be in-charge of the government Scholarships provided to the students.
6. The selection of scholarship awards will be based on the required criteria for the scholarship provided.
7. The scholarships will be provided only to the students of St. Francis de Sales College, Bangalore.

List of Scholarships:

1. Learn at SFS Scholarship

Eligibility Criteria: Scholarship will be given to the financially weaker students who seek admission from the College to SFS Degree College.

Amount of support: Rs. 1500

2. Meritorious Scholarship

Eligibility Criteria: Scholarship will be given to the students who procure university ranks.

Amount of support: Rs. 2000.

3. Proficiency Scholarship

Eligibility Criteria: The Proficiency Scholarship will be awarded to the Batch toppers for every semester of the academic year.

Amount of support: Rs. 1000

4. SSA Scholarship

Eligibility Criteria: The Scholarship will be awarded to the financially weaker students and the amount will be decided by the management based on the need of the student who applies for the same.

5. MSFS Scholarship

Eligibility Criteria: Christian minority students who excel in their academics, co-curricular and provide service to the society.

Amount of support: Rs. 2000

6. International Students Scholarship

Eligibility Criteria: The scholarship will be awarded to International students who secure above 50% in Class XII and apply for the scholarship.

Amount: It varies depending on the sponsoring agency.

7. Fr. Raison Memorial Scholarship:

Eligibility Criteria: This scholarship will be sponsored by the Suvidya College (Institute of Philosophy and Social Sciences) and will be awarded to the topper who resides in the college hostel.

Amount of support: Rs. 10000

8. Centum Scholarship

Eligibility Criteria: The scholarship will be provided to students who secure centum in their respective subjects in the university exams.

Amount of Support: Rs. 1000.

9. Rising Star Scholarship

Eligibility: The scholarship will be provided to students who excel in co-curricular and extra-curricular activities in an academic year.

Amount of Support: Rs. 1000.

10. Girl Child Scholarship

Eligibility Criteria: The scholarship is given to deserving students, especially from financially weaker background and who shows potential to excellence.

Amount of Support: Rs. 2000 will be given to

15. Cultural Scholarship


Eligibility Criteria: The Scholarship will be awarded to the students who excels in cultural.
