#### **ANNEXURE-1**

#### **TERMS & CONDITIONS OF EMPLOYMENT**

Your employment is governed by the following:

- Work Location & Department: You will be working out of the Company's office in Bangalore, Karnataka. The Company may, at its sole and absolute discretion, transfer your services to the other offices of the Company, located within India or outside India, from time to time, after following the due procedure set out under applicable law. You shall always be required to abide by the Company's Rules and Regulations and the Policies of the Company, during the tenure of your employment with the Company. - 2) Salary: Your cost to company (hereinafter referred as "CTC") shall be an amount equal to INR 8,50,000 per annum, as further detailed in <u>Annexure-2</u>. The CTC shall be inclusive of all statutory levies. In all such cases the Company shall provide appropriate certificate(s) as mandated by applicable law.
- Working Hours: The Company works Monday through Friday. You would be required to work hours as per the requirements of the Company.
- 4) Probation: The probationary period you will serve with the Company will be Three (3) months and the Company reserves the right to extend your probationary period or terminate your employment in case there are performance, behavior and / or conduct issues during the probation period and is found unsatisfactory at the sole discretion of the Company. Confirmation shall depend upon satisfactory review of your performance and conduct during the probation period. You shall not be entitled to take any type of leaves during the probation period. If any leaves are taken your probation will be extended accordingly.
- Selinquishment of Service: You shall be entitled to resign from the services of the Company by giving two (2) months written notice or by tendering gross salary in lieu of the equivalent to two (2) months' notice, subject to acceptance of the same by the Company. Likewise, the Company shall be entitled to relieve you from the services of the Company by giving two (2) months' notice or two months gross salary in lieu. However, in case of dismissal / removal or termination of your services for misconduct, fraud or breach of any of the terms & conditions of the services, the Company shall give you a notice stating the cause for termination. The Company shall provide you with the right to refute any determination of the ground of termination as specified in such notice, and any termination by reason of such determination shall be effective once you are afforded an opportunity of fair and impartial hearing on the principles of natural justice. With reference to points i & ii mentioned above under relinquishment of service, resignation once submitted and received by the Company, cannot be withdrawn by you except through a written consent from the

- i) You shall also not disclose to any person & / or organization & / or competitor any confidential and proprietary information which you have access to during your course of employment, which is presented to you by the Company or developed, conceived or created by the Company, or disclosed to you or known by or conceived or created by you during the term of your employment by the Company, with respect to the Company, including any information, its business or any of its products, processes, and other services relating to the past, present or future business of the Company or any plans therefore, or relating to the past, present or future business of a third party or plans therefore which are disclosed to you. Confidential Information includes, but is not limited to, all documentation, hardware and software relating thereto, and information and data in written, electronic, graphic and/or machine readable form, products, processes and services, whether or not patentable, capable of being trademarked or copyrighted or otherwise protected, including, but not limited to, information with respect to discoveries; know-how; ideas; computer programs, source codes and object codes; designs; algorithms; processes and structures; product information; marketing information; price lists; cost information; product contents and formulae; manufacturing and production techniques and methods; research and development information; lists of clients and vendors and other information relating thereto; financial data and information; business plans and processes; documentation with respect to any of the foregoing; and any other information of the Company that the Company informs you about or you should know, by virtue of your position or the circumstances in which you learned such other information, which also includes any other information available with the Company with regard to our customers and clients ("collectively, the Confidential information").
- ii) Except as authorized by the Company or required in the performance of your duties as an employee of the Company, you will not, during or after your employment, directly or indirectly, use any Confidential Information or disseminate or disclose any Confidential Information to any person, firm, corporation, member of the press, association or other entity. You shall take all reasonable measures to protect Confidential Information from any accidental, unauthorized or premature use, disclosure or destruction. You will be responsible for, and required to sufficiently encrypt and otherwise protect, any information contained on any laptop computer or any removable drives or backup devices that you may use either inside or outside of the Company's office.
- iii) You shall not participate/associate for commercial gains or otherwise with any competitor and / or Company carrying on similar business as that of our Company and also not commence a similar business either on your own or with any other person or persons during the period of your employment. During the term of your employment, you further agree that you will devote all of your business time and attention to the business of the Company, the Company will be entitled to all of the benefits and profits arising from or incident to all such work services and advice.



- iv) Without limiting the rights of the Company in respect of a breach of this clause, you shall:
  - (a) promptly notify the Company of any unauthorized possession, use or knowledge, or attempt thereof, of the Confidential Information by any other person, that may become known to you;
  - (b) promptly furnish to the Company full details in its possession, of the unauthorized possession, use or knowledge, or attempt thereof, and assist the Company in investigating or preventing the recurrence of any unauthorized possession, use or knowledge, or attempt thereof, of the Confidential Information;
  - (c) cooperate with the Company in any litigation and investigation against third parties deemed necessary by the Company to protect its proprietary rights; and
  - (d) promptly use your best efforts to prevent a recurrence of any such unauthorized possession, use or knowledge, or attempt thereof, of Confidential Information.
- v) Upon termination of your employment with the Company for any reason or at any time upon request of the Company, you agree to deliver to the Company all materials of any nature which are in your possession or control and which are or contain Confidential Information, or which are otherwise the property of the Company or any vendor, licensor, licensee, customer or client of the Company, including, but not limited to writings, designs, documents, records, data, memoranda, tapes and disks containing software, computer source code listings, routines, file layouts, record layouts, system design information, models, manuals, documentation and notes.

#### 7) Non-compete and Non-solicit Clause:

- (a) You shall not, during the tenure of your employment with the Company and for a period of 1 (one) years thereafter, directly or indirectly, whether jointly and / or severally or together with any other person (including, any combination thereof) incorporate, promote, join, engage, enter into or associate yourself in any capacity whatsoever or be interested in or concerned in any manner with a competing business, in whatever form and wherever organized, to that of the business of the Company, as now or hereafter may be carried on (or agree to or enter into or participate in any negotiations or discussions to do all or any of the foregoing).
- (b) You shall also not engage or involve any employee of the Company, in the case of ownership & management of a similar business as of the Company by you, for a period of 1 (one) year from the last date of your service with the Company.
- (c) During your tenure of service in the Company, if your spouse engages in any activity that is in competition with the business of the Company, you shall promptly notify the same to the Company in writing to seek approval from management.
- (d) You shall not, attempt in any manner to solicit from any client/customer or partner except on behalf of the Company, business of the type carried on by the Company at any time or to persuade any person, firm or entity which is a client/customer or

partner of the Company to cease doing business or to reduce the amount of business which any such client/customer or partner has customarily done or might propose doing with the Company whether or not the relationship between the Company and such client/customer or partner was originally established in whole or in part through his or its efforts.


