C. The Parties intend to cooperate and focus their efforts on cooperation within the areas of Skill Based Training, Education and Research to help student clear the Competitive exams such as Banking, Staff Selection Commission (SSC), UPSC - CDS (Combined Defence Services), UPSC - CDS OTA (Officers Training Academy).

CLAUSE 1

CO-OPERATION

1.1. Both Parties are united by common interests and objectives, and they shall establish channels of communication and co-operation that will promote and advance their respective operations within the **Institution** and its related wings. The Parties shall keep each other informed of potential opportunities and shall share all information that may be relevant to secure additional opportunities for one another.

1.2 First Party and Second Party co-operation will facilitate effective utilization of the intellectual capabilities of the faculty of First Party providing significant inputs to them in developing suitable teaching / training systems, keeping in mind the needs of the industry, the Second Party and help students on regular bases to upskill their capabilities.

1.3 The general terms of co-operation shall be governed by this MOU. The Parties shall cooperate with each other and shall, as promptly as is reasonably practical, enter into all relevant agreements, deeds and documents (the 'Definitive Documents') as may be required to give effect to the actions contemplated in terms of this MOU. CLAUSE 2

SCOPE OF THE MOU

2.1 The budding graduates from the institutions could play a key role in technological up-gradation, innovation and competitiveness of the competitive exams such as Banking, Staff Selection Commission (SSC), UPSC – CDS (Combined Defence Services), UPSC - CDS OTA (Officers Training Academy). Both parties believe that close co-operation between the two would be of major benefit to the student community to enhance their skills and knowledge to clear the competitive exams and secure the jobs if they follow the instructions and directions provided by the First Party with 100% dedication. The placement services shall be provided by the First Party on the basis of conditions provided in clause 2.8.

2.2 Curriculum Design:

The First Party will do all the curriculum design, put the course together. First Party will give valuable inputs to the students of Second Party in training methodology and suitably customize the curriculum so that the students can clear the Competitive exams such as Banking, Staff Selection Commission (SSC), UPSC – CDS (Combined Defence Services), UPSC - CDS OTA (Officers Training Academy).

2.3 Scope of Training & Program:

2.5 Skill Development Programs:

First Party to train the students of Second Party on the competitive exams in order to bridge the skill gap and make them ready 100% to crack these exams provided the students of the Second Party follow all the instructions and directions provided by the First Party with 100% dedication.

2.6 Instructions and Directions:

First Party will give 100% assurance on cracking the examination only if below instructions were followed from students:

1. 100% attendance for all online classes
2. 100% syllabus completion (Students should complete watching all videos, take all practice tests and score minimum 80% in all of them)
3. Minimum 85% score in all the Mock Tests

2.7 Expert and Doubt Clearing Sessions:

First Party to extend the necessary support to deliver Online expert sessions and Doubt clearing sessions to the students of the second Party while preparing for the competitive exams.

2.8 Placement of Trained Students:

This is subject to students of Second Party to successfully crack the respective competitive exams. The First Party will train students in a way which can help them to clear the exams with 100% assurance provided the student follows the instructions and directions provided by the First Party (see section 2.6) with 100% dedication.

2.9 Financial Commitment:

There will be below mentioned financial commitment (See Annexure I) on the part of the students who join for this program. If there is any other financial consideration, it will be dealt separately.

2.10. Commercial Terms

2.10.1 The fee will be collected by the First Party, and payment receipts/bill should be issued accordingly by the First Party. Any number of students can enroll to the course by making the full fee payment, must be considered for classes/courses.

- 2.10.2** Ensure the students are told clearly about the fees, taxes, duration of the course, internship, class timings etc., and fees once paid will not be refunded, even if the student cancels the admission in the College or discontinues from the programme offered by First Party.
- 2.10.3** The First Party shall not make any payment to any employee of the College or to anyone for any favours or assistance received in executing this MOU, either in Cash or in kind without the written permission of the Principal.
- 2.10.4** Once the classes/training begin, a report of the enrolment of students for each course, fee payment, attendance, assessment, internship, placement, etc., must be submitted to the Principal by 28th of every month by mail (principal@sfscollege.in). A copy of the same mail can be sent to the Placement Cell of the College (placement@sfscollege.in) for reference and follow up.
- 2.10.5** Any on campus training sessions/classes can be conducted only between 02:30pm to 05:30pm (Monday to Saturday) or on public holidays from 10am to 4 pm. Online classes/training can happen after 2.30pm. We don't permit students from any other institutions to our campus without the written permission of the principal. Any infrastructural needs (classroom/computer lab) etc., will be made available only after considering the university requirements placed on the college by the university.
- 2.10.6** As the fees is collected by the First Party, the Infrastructure/Institutional cost of 15% of the fees collected must be paid to SFS College by the end of the course completion every semester.
- 2.10.7** SFS College will not be responsible in assuring the number of students enrolling for the program. The First Party can have their staff in our college premises with prior permission from the principal to explain the specialties of the course & counsel the students for the course accordingly.
- 2.10.8** Placement assistance support will be provided by the First Party for the students undergoing this training program. This is subject to students of Second Party to successfully crack the respective competitive exams. The First Party will train students in a way which can help them to clear the exams with 100% assurance provided the student follows the instructions and directions provided by the First Party (see section 2.6) with 100% dedication.
- 2.10.9** Any requirements from the part of the College, financial deals, etc., must be brought to the notice of the Principal for approval before execution.

CLAUSE 3

INTELLECTUAL PROPERTY

CLAUSE 4

VALIDITY

4.1 This Agreement will be valid ^{two years (3)} until it is expressly terminated by either Party on mutually agreed terms, during which period **EDURapid**, the First Party, as the case may be, will take effective steps for implementation of this MOU. Any act on the part of **Second Party**, the First Party after termination of this Agreement by way of communication, correspondence etc., shall not be construed as an extension of this MOU

4.2 Both Parties may terminate this MOU upon 30 calendar days' notice in writing. In the event of Termination, both parties have to discharge their obligations

CLAUSE 5

RELATIONSHIP BETWEEN THE PARTIES

5.1 It is expressly agreed that First Party and Second Party are acting under this MOU as independent contractors, and the relationship established under this MOU shall not be construed as a partnership. Neither Party shall have, nor represent itself as having, any authority under the terms of this MOU to make agreements of any kind in the name of or binding upon the other Party, to pledge the other Party's credit, or to extend credit on behalf of the other Party.
