Strengthening community engagement initiatives to enhance the company's commitment to social responsibility.

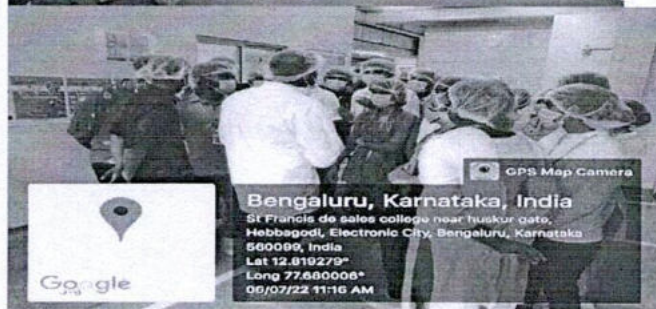
