This Memorandum of Understanding (MOU) between IT Champs Academy and Saint Francis De Sales College made at Mysore on this day Friday 28th of August 2018

Between:

IT Champs Academy, hereinafter called "IT Champs", a firm situated in 219/1, Hebbal Industrial Area, Belavadi Post, Mysore 570018 and authorized to provide training in SAP from SAP India Private Limited is desirous of providing SAP Power User Training Courses to students through universities & large institutions.

And

St. Francis De Sales College, hereinafter called "Institution" NH 44, Kammasandra, Electronic City Bangalore-560100, has expressed their interest in providing such training as detailed above to their students in line with the terms and conditions laid down by IT Champs more so detailed in the document below:

HENCE THIS MEMORANDUM IS NOW MADE AND THE PARTIES HERETO AGREE AS FOLLOWS:

General Terms

1. IT CHAMPS has appointed the Institution initially for a period of One Year from the date of this agreement to conduct training on "SAP Power User" course in the Institution's premises as listed above in the preamble. The agreement can be renewed by mutual consent for one year at a time subsequently.
2. This MOU is non-transferable. The Institution shall not change the constitution without providing written notice to IT Champs. The Institution shall not have a right to sub-let or start a sub-centre without permission from IT Champs.
3. This program has been designed and priced specifically for Educational Institutions. The institution shall offer the SAP Power User course to candidates only in the premises as mentioned above. The institution shall not approach any other institution, college, university or by whatever name called to re-sell this program.

Delivery and Training

4. The institution shall make available all details of the candidate seeking admission to the course to enable registration on SAP portal. No candidate shall be allowed to commence training unless the registration is completed by IT Champs and approval is issued through a notification.
5. All candidates will be issued a photo identity card from IT Champs which the candidates will be required to be carrying on their person at all times during the course.
6. IT Champs will, through its authorized partner, provide onsite training on the module to the students. The timing of the training will be discussed and agreed with the institution's management; A total of 30 hours of onsite training will be imparted in line with the course curriculum. The entire program is expected to be completed over a period of 3 Months.
7. The trainer will provide training to the registered candidates only.
8. The training will be provided at the designated premises of the institution. The institution shall ensure availability of computer hardware including audio headset, UPS back-up and suitable internet connection to log-in and use the SAP Power User Course. IT Champs can provide assistance in evaluating the requirements of hardware and internet connections wherever required.
9. IT Champs will conduct an evaluation of all the students at the end of the program.
10. All candidates who complete the full course and pass the assessments will receive a **SAP Power User Program** certification from IT Champs.

Commercial Terms of this program are provided in Annexure-1.

11. Institution shall raise a purchase order together with an advance payment for procuring SAP Power User Course Licenses in bundles of agreed numbers based on category of contract.
12. IT Champs shall invoice and make available the required licenses to the institution from its offices in Mysore/Bangalore.
13. Each license is registered against a particular candidate who has sought registration. It is not permitted to use the license registered for one candidate for another un-registered candidate.
14. Licenses once issued and registered against an institution cannot be revoked and hence any payments made by the institution will not be refundable under any circumstances.
15. In case of any dispute arising out of this agreement, the matter unless resolved by mutual agreement of the parties shall be transferred for judicial proceedings. Any suit and proceedings arising out of this contract shall be instituted in the Law Court of Mysore City Jurisdiction only.
16. IT Champs does not provide any guarantee for provision of jobs or placement assistance to candidates enrolling for the SAP Power User Program.
17. The institution absolves IT Champs of any civil or criminal claims by any candidate or his representative over the program or delivery of the course.

Marketing and Publicity:

18. The institution shall obtain approval of IT Champs on the content, design, graphics or any other material used for marketing or publicity prior to conducting any media activity, either in print, electronic or digital media.
19. IT Champs shall make available to the institution all logos and marketing information and content necessary for creation of marketing material.
20. The institution shall display at a prominent and visible location the logos of "IT Champs SAP Partner" in the same size and at the same height in the marketing collateral and boards, within their premises.

Confidentiality

21. The institution shall maintain confidentiality on the cost and product pricing received from IT Champs and any other information of sensitive nature.
