St. Francis de Sales (SFS) College is managed by the Missionaries of St. Francis de Sales (MSFS) of South West India Province, who firmly believe that 'the education of the heart is the heart of education hailed by its founder Fr. Peter Marie Mermier.

St Francis de Sales College came into existence in 2004 with the motto: Excellence, Transformation and Efficiency. It is a minority recognized institution, permanently affiliated to Bangalore University with UG, PG (including MBA) and PG Diploma Programs.

In the year 2018, the College obtained 2(f) and 12(b) recognition under the UGC Act of 1965. AICTE approval for MBA was obtained in 2020. The College was granted "B++" grade by the NAAC in 2021. The College is also an ISO certified Institution.

Details of JAC Academy, Bangalore

JAC Academy, with the parental organization as JAC Group of Educational Institutions, established in 2019, is in the field of providing education and training of students Skill Enhancement, Placements & certificate programmes and has proposed to the first Party, its desire to conduct classes on Logistics & Shipping, Logistics & Supply Chain Management, Clinical Research & Advanced Marketing Management, for the students pursuing Under graduation at the College campuses under the ownership and management of first Party as well as Online mode.

Purpose of the MOU

The purpose of this Memorandum of Understanding (MOU) is to formally create a mutually beneficial working relationship between SFS College and JAC Academy for providing add-on courses for skill enhancement.

In particular, the MOU is intended to

- To facilitate the provision of add-on courses By JAC Academy to the students of SFS College, Bengaluru
 at a price which will be mutually agreed upon, for each course.
- To jointly provide for experiential and hands-on learning for students of SFS College.

To provide relevant educational services at the agreed consideration.

To utilize the college resources and infrastructure for the fulfilment of the purpose of this MOU

Duration

This MoU is for a period of 3 years. It can be extended further by mutual consultation and agreement.

Co-ordinators

- SFS College: Asst Prof. Mr.Druva Kumar K S, Department of Commerce will serve as the Coordinator.
- JAC Academy: Ms Sushmita Nayak, CMO will serve as the coordinator, and will sign as witness in the MoU document.

The respective Coordinators of SFS College and JAC Academy shall be responsible for all the communication between the two institutions and the implementation of the proposed objectives of the MoU.

Administration of the signed MoU

- This MoU shall be effective and will come into force from the day the two authorized signatories of both the parties formally sign the MoU document.
- The authorized signatories and/or the Coordinators of SFS College and will

o Implement this MoU and all endeavors that derive from it.

Develop and carry out joint plans for the implementation of the objectives of the MoU by having regular communications.

Additional activities proposed within the framework of the general terms of this Memorandum of Understanding will be formally incorporated as an addendum to this MoU, provided the addendum is agreed to and signed by both parties.

 Both SFS College and JAC Academy shall inform in writing the respective communities of this MoU to draw benefits from it and to contribute towards its implementation in spirit and substance.

Termination / Amendment of MoU

 Both the parties will endeavour to resolve disputes arising between them in relation to this MoU by amicable means. In the event of any irreconcilable differences, the MoU may be terminated by mutual consent of the two parties.

Either party may terminate this MoU by written notification signed by the appropriate official of the

institution initiating the notice.

 A minimum of three months prior notification shall be sent to the other party prior to the effective date of termination.

Intellectual Property Rights

Intellectual Property developed by the joint efforts would be the joint property of the Parties and any financial benefits or otherwise arising out of it shall be shared proportionately by the parties ir consonance with the efforts / inputs given by them.

Jurisdiction

All disputes are to be settled within the jurisdiction of Bangalore courts, State of Karnataka.

Undertaking by SFS College and JAC Academy

Both the parties undertake to work closely and cooperate in the implementation of this MoU. The authorized representatives, including the signatory and the coordinator related to this MoU acknowledge having read and understood the MoU and agree to be bound by its terms and conditions.

SPECIAL TERMS

• The program details sent by JAC Academy, will be shared with the students during the admission process/at the beginning of a new semester. Students are free to enroll in any program that interests them.

• Ensure the students are told clearly about the fees, taxes, duration of the course, internship class timings etc., and fees once paid will not be refunded, even if the student cancels the admission in the College or discontinues from the programme offered by JAC Academy.

• JAC Academy, agrees that it will submit copies of all materials, written or electronically made (such as, but not limited to, videos, tapes, Internet home-pages etc.) that represent the College or bear the College's name or logo to the College's approved representative.

JAC Academy, is not authorized to and shall not accept payments from students other than
that is clearly agreed upon and mentioned in this MOU without the written permission form
the Principal. Students shall make all payments directly to JAC Academy, will issue their
receipt for all the payment received.

• JAC Academy, shall not make any payment to any employ of the College or to anyone for any favours or assistance received in executing this MOU, either in Cash or in kind without the written permission of the Principal.

 SFS College will not guarantee any number of students for the training program. However JAC Academy, can advertise their courses using standees, banners, etc.,

• JAC Academy, should make sure that they employ their personals (or compensate the employees of the college) during their hours of training, fees collection, etc. Any employee of the college can be utilized by JAC Academy, only with the written permission of the Principal.

• The fees will be collected by JAC Academy, through online/offline payment. The college will not take the responsibility of collecting the fees.

• The training sessions/classes can be conducted only between 02:30pm to 05:30pm (Monday to Saturday) or on public holidays from 10am to 4 pm in the college premises. We don't permit continue to the students from any other institutions to our campus without the written permission of the principal. Any infrastructural needs (classroom/computer lab) etc., will be made available only after considering the university requirements placed on the college by the university.

If the training sessions/classes are conducted online only on unavoidable circumstances

JAC Academy, will need to ensure the entire process is managed end to end by themselves.

- Once the classes/training begin, a report of the enrolment of students for each course, fee payment, attendance, assessment, internship, placement, etc., must be submitted to the Principal by 28th of every month by mail (principal@sfscollege.in). A copy of the same mail can be sent to the Placement Cell of the College (mou@sfscollege.in) for reference and follow up.
- Any requirements from the part of the College, financial deals, etc., must be brought to the notice of the Principal for approval.
- The college will mention the logo of JAC Academy, in the college website as a learning partner.
- JAC Academy, will ensure to keep the infrastructure, computers, lab equipment's facilities, etc., provided by SFS College intact, in case of any loss to the above mentioned compensation will be made by JAC Academy, accordingly.
- TERMS OF PAYMENT: As the fees is collected by JAC Academy, the Infrastructure/Institutional cost of 15% must be paid to SFS College by the end of the course completion every semester.
- FEES: The fee will be collected by JAC Academy, and payment receipts/bill should be issued accordingly by JAC Academy. Any number of students can enrol to the course by making the full fee payment, must be considered for classes/course.
- BATCH SIZE: SFS College will not be responsible in assuring the number of students
 enrolling for the program. JAC Academy, can have their staff in our college premises to explain
 the specialties of the course & counsel the students for the course accordingly
