1. **Seed Money:** For eligible and approved project proposals, a seed money grant of Rs. 10,000 – Rs. 50,000 is provided to the Principal Investigator,
2. **Full Funding:** For eligible and approved project proposals, full funding is provided to the Principal Investigator. Full funding is limited to a maximum of Rs. Two lakhs per project.

Who can apply

Any Full Time Faculty with a Ph.D. Degree may apply for the project funding, provided that

1. The faculty has not availed of such opportunity in the past from us.
2. Any faculty may receive funding for one proposal at a given time.
3. The faculty is not engaged in any other research activity at the given time.

Faculties holding PG but not Ph.D. may also apply provided

1. The faculty has not availed of such opportunity in the past from us.
2. Any faculty may receive funding for one proposal at a given time.
3. The faculty is not engaged in any other research activity at the given time.
4. The faculty has demonstrated expertise in the related field.

The Research Project must be completed at the given deadline with the agreed upon intended deliverable. Failure to do so will require the Principal Investigator to refund the entire amount paid to them within thirty days of receiving such notice to refund the money alongwith interest.

The Research Projects to be completed within a time limit not exceeding one year will be considered for approval.


For every project funded and completed, the Principal Investigator must publish at least two papers in reputed journals recognized by UGC within two months of the date of completion of the project. Failure to do so will constitute as violation of terms of funding and may require the Principal Investigator to refund the money provided as assistance within thirty days of completion of two months from date of completion of the project.

The institution must have adequate research facility to support the faculty for the research activity.

Utilization of grant

The grant may be utilized for the following purposes:

1. Purchase of books, journals or any other e-content relevant for the research work. The books, journals and other e-content such purchased must be deposited to the institution library after completion of the project and a receipt must be produced.
2. Purchase of minor equipment on prior approval.
3. Hiring Technical Assistant. However, hiring must be pre-approved by Campus Technology. Campus Technology may provide resources for the intended work or may recommend resources to be hired for the intended work.

4. Expenditure related to travel and field work will not be covered under this grant.
5. The grant may be utilized for consumable items required for the proposed research work.
6. Utilization Certificate of the Grant must be endorsed by a chartered accountant listed in the panel of Campus.Technology and produced at the completion of project. Failure to do so will require refund of the money provided as project funding. The cost of audit to be borne by the Principal Investigator.
7. All projects must be completed within a maximum time limit of one year from the date of receiving the fund, with intended deliverable. Failure to do so will require refund of the money provided along with interest.

Intellectual Property Right

The Intellectual Property Right arising out of the final outcome of the research activity will be jointly shared between Kahan technologies Pvt Ltd and the Principal Investigator. The Principal Investigator must file for Patent/Copyright with Kahan technologies Pvt Ltd as a co-owner of IPR within thirty days of completion of the project and the receipt must be produced. The final decision will be conveyed to the Principal Investigator within sixty days of receiving the application.

3 Guideline for Institutions

We provide cloud based software for accreditation management and campus automation to the institutions at no cost. We also conduct Academic Audit and Administrative Audit, and Green Audit for the institutions and provide guidance for quality improvement and accreditation management, at no cost, provided that

1. Institution understands and agrees that Total Quality Assurance (TQA) Program is an integrated program for Institution, Faculties and Students and must be availed by all. This program is not available in parts, i.e., without the active participation of all three stakeholders.
2. At least 30% of the faculties participate in Research Project Application or Consulting Engagements and Development of e-content and online course material.
3. At least 50% of the students must participate every year in the Student Empowerment and Corporate Employability Program.
4. There is no cost for the institution or faculties, however students need to pay a onetime registration cost as detailed in section 4 and avail all the services. Rest of the fund for institutions, faculties and students are provided by us.
5. Failure to implement active participation of all three stakeholders within one month of engagement will lead to automatic withdrawal of the program.
6. A cloud based software will be provided along with mobile app for faculties and students. The data will be stored in the cloud. Institution will own the data during the active subscription period and may be downloaded any time as an offline copy.

The payment gateway is provided free of cost by a third party and is integrated with the software. The payment gateway may be used for collection of any type of fees or registration cose.

Implementation of the Program

The TQA Program is implemented through the Internal Quality Assurance Cell (IQAC) of the institution as follows.


