It is agreed and between the parties as follows: -

Whereas **M/s. Mithra Multispeciality Hospital** is engaged in providing Medical Care, Hospitalization Services, Out-patient Services and Ambulance Services.

Whereas **M/s. SFS Degree College & Postgraduate Centre**. Is engaged in educational institution.

Whereas the **Receiver** has requested the **Provider** to extend Emergency Medical Services, Annual Health Check Up, Routine Medical Services, Ambulance Services to employees and students of their Institution

Whereas the **Provider** has understood the requirements of the **Receiver** herein agrees to provide Emergency Medical Services and Routine Medical Services, Annual Health Check Up, Ambulance Services, Hospitalization and Treatment and Diagnostic Service.

Whereas the **Receiver** hereby confirms to authorize the **Provider** to extend such treatment to its Employees on production of ID card or Authorization Letter from Institution. Further the **Receiver** confirms that the employee will take the benefit on credit facility.

Whereas, based on mutual promises and on the consideration contained herein, the adequacy whereof is hereby acknowledged, the parties agree to this Agreement.

1. 15 days credit facility shall be provided only when referred with an authorization letter from the Institution.

Monthly bills are submitted to institution and the payment should be made within 15 days from the date of Invoice received. Credit Invoice will be raised on **M/s. SFS Degree College & Postgraduate Centre**

2. If Employees / Student visit hospital as walk-in, the payment will be made immediately by the Employee/ Student after the services availed, however the standard discounts will be applicable.
 3. To avail credit service during emergency admission / Sundays / Holidays, the authorization letter from the institution has to be produced to admission department on the next working day. Mithra Multispeciality Hospital staffs can also verify with HR or Deputed Person for its authentication.
 4. The Agreement is valid for 'One Year' from agreement signed date and could be renewed every year thereafter with a mutual consent.
