The Commerce Department at St. Francis de Sales hosted a seminar on "Research and Professional Ethics" on 18th February 2023. Online via Google meet.

The objective of the Seminar was basically to ensure that the students develop critical thinking skills that will help them to recognize potential ethical dilemmas. This workshop was conducted to draw the attention of all towards the problems and challenges that are there in front of us at the levels of individual, family, society and nature. This workshop is mainly to increase ethical knowledge and improve ethical thinking.

There were approximately 67 student participants and 2 faculty participants who attended the seminar. The session started with a prayer and opening remark was given by Dr. Siny Philip where she introduced the Speaker, Dr. Asadi Srinivasulu

Further, the speaker took over the session and started off by diving right into the topic 'A layman's perspective on personal and professional ethics.' He emphasized that professional ethics are an extension of personal ethics. He also mentioned that ethics change from time to time and from situation to situation depending on the frame of reference. Through comparative analysis he explained five basic properties of professional ethics codes: universal distribution, correlation with intra



professional status, enforcement dependent on visibility, individualism, and emphasis on colleage obligations. After discussing traditional explanations of these properties from the functionalist and monopolist perspectives, he adds a third perspective, relating ethics directly to intra-and extra pofessional status

## The outcome of the program:

The training improved participants' knowledge of principles of research ethics, international guidelines and regulations and operations of IRBs. It thus provided an opportunity for research ethics capacity development among students and academic staff in a developing country institution.
