A debate was conducted as a class activity on 26/10/2021 for the final year BCA which was moderated by Prof. Annie Christilla, the class co-ordinator for the final year BCA. The debate helped students to think and share their views on the provided topic. The debate was about the views of the locals toward the migrants, the problems faced by the migrants, are the migrants a boon to the local residents or a curse, if the migrants were starting to dominate the local culture, thereby causing damage to the local culture. It was Kannadigas vs the migrants.

The entire class was divided into two with one alliance representing the people of Karnataka while the other backing the migrants. (These two teams will be represented further as Team A and Team B.) While most of the students backed team A, Team B was “short-staffed”. Members from both the teams performed admirably.

The session went on for approximately 40 minutes with both the teams engaging in a fierce yet non-brutal war of words with the battle spearheaded by the representatives from each team led by Ravi Kumar (Team A) and Geo Melvin (Team B).

The students gave their views to support and justify their teams or what they stand for. The debator from Team A started the debate by telling that migrants do not know the local language

and they have to learn the language and that the migrants should not expect to force their language on the locals. He gave the example of how Hindi is being forced on the locals and how the people coming from other states force the locals to speak in Hindi.

To which a debator representing team B admitted that what the migrants do is wrong but he also justified that there are migrants who learn the local language and communicate in the local language. Not all the migrants force the locals to talk in their language.

Also that Hindi is not only being forced on the locals but also non-hindi speaking migrants.

The next debator from Team A pointed out that the commercial outlets set up by migrants have their name boards printed in their language and ignores the local language

To which debator from Team B said that it wasn't true as the BBMP had either fined or pulled down the name boards not having Kannada on it. And since it is against law to put up name boards without a common language and the local language, nobody dares to put up name boards without local language. Another debator from Team B pointed out that the transport system of the state has to use a common language so that the migrants can understand and so it becomes easier for the migrants to board the transport.

The debator from Team A justified that there are route numbers can be checked. He was then countered by a Team B member who asked him how they remember the route numbers. Then a debator from Team B pointed out that making kannada mandatory will only affect the locals as the student intake would be reduced drastically. As the time was about to end, the moderator stepped in to clarify that the mandatory kannada wasn't the complex Kannada studied by students, but the basic Kannada required to survive in Karnataka.

As the conclusion the moderator said that Kannadigas are being submissive and that is the reason for the domination of migrants and that since the migrants are coming into Karnataka for their livelihood, they have to blend in with the local culture. Also the migrants are being discriminated in many ways which has to be stopped.

Overall, the session was wonderful, informative and interesting. The points put forth by the students were superb and finally, it was a very interactive session.
