## DESALITE ENDOWMENT FOR RESEARCH AND DEVELOPMENT

Desalite Endowment for Research and Development is an endowment provided by St Francis Sales Educational and Charitable Trust, for the Faculty and Students of St Francis de Sales College, Electronic City, Bengaluru.

This endowment is for Short Term Research Project proposals. The eligibility criteria and amount of the endowment is decided for every Academic Year, and is duly approved by the Management.

## ELIGIBILITY CRITERIA OF THE ENDOWMENT - ACADEMIC YEAR 2021-22

- The Applicant must be a Faculty member of the College and must be competent to undertake the research
- The project duration is to be for minimum two months, but not exceeding one year
- The project objectives must be feasible in terms of resources and time allocated.
- The project must have a clear and justified budget.

#### PROCEDURE FOR APPLYING

- All the eligible faculty members may submit their project proposal in the prescribed format.
- The filled Application Form (https://www.sfscollege.in/Research.php) is to be sent in MS-Word format to research@sfscollege.in and a hard copy addressed to Principal, St Francis de Sales College is to be submitted to the Research Cell on or before 03-03-2021.
- Incomplete Application forms will not be accepted.
- Any faculty member of SFS College can apply for this endowment

## PROCEDURE FOR APPROVAL

- The received proposals will be assessed with the help of a subject expert committee constituted by the College.
- The final decision will be taken by the management on the basis of recommendations made by the Committee and the availability of funds under the endowment scheme.

#### POINTS TO REMEMBER

- The proposed scientific studies should have clear aims and objectives where the methods are clearly explained and the questions asked within the application form are appropriately answered.
- There will be no provision for the payment of course fees (of any type) of the applicant or appointment of any staff under the project.
- The project funds will not be used for national or international travel for attending conferences/seminars.
- The Principal Investigators/Institutions (PI) are expected to settle the accounts within 60 days on completion of the project.
- Project is not transferable in any case.
- The Principal Investigator is not supposed to leave the institution within one year after the project completion or before publishing a paper or IP whichever is earlier.
- If the Principal Investigator fails to complete the project, he/she has to refund the entire amount released with interest.
- The affiliation of the author should be "St. Francis de Sales College, Bengaluru 100" in all Publications and IP generated through the project and all online communication should be made only through the College Official Email ID



#### **Desalite Endowment for Research**

#### General guidelines for Project management

#### Fund Dispersal and management

Management would fix on an amount to be released for Research through Desalite Endowment for Research per year. Accordingly the proposal can be selected. PI (Principal Investigator) would be asked to specify the budget according to the given format. The categories under which the expenditure can be are Manpower, consumables, travel, equipment, consultancy, any other.

Once the project proposal has been approved by the committee, the fund for execution of the project would be released part by part.

Certain expenditure would be continued after completion of the project, like softwares', equipment or tools. In such cases, equipment would be purchased by the college and the bill would be given to the PI for documentation.

Amount would be dispersed to the PI account.

A letter stating the amount sanctioned for the respective project would be given to the Pl and the same documented in the HR department.

Undertaking from PI before dispersal of amount would be taken before the dispersal of amount of each installment.

Each bill has to be submitted after the completion of the project. Vouchers can be used for TA/DA or expenditures which cannot produce bills.

Documentation on every expenditure has to be maintained by PI. Each amount spent should be specified and file the related documents. Each rupee spent should be accounted for.

The proposed scientific studies should have clear aims and objectives where the methods are clearly explained and the questions asked within the application form are appropriately answered.

The project funds will not be used for national or international travel for attending conferences/seminars.

The Principal Investigators/Institutions (PI) are expected to settle the accounts within 60 days on completion of the project.

Project is not transferable in any case.

The Principal Investigator is not supposed to leave the institution within one year after the project completion or before publishing a paper or IP - whichever is earlier.

If the Principal Investigator fails to complete the project, he/she has to refund the entire amount released with interest.

#### Progress Report

Progress report of the project should be submitted to the Research Cell once every 3 months. Fund would be released after the submission of the progress report.

Timeline should be given by the PI with the synopsis for having a clear picture on completion of the project and also to monitor the progress of work

A deadline should be given by the PI to have a structure follow up.

### Appointments and Leave

There will be no provision for the payment of course fees (of any type) of the applicant or appointment of any staff under the project.

If project work requires going outstation for data collection and any related work, leave would be granted with prior permission with all the details and without affecting academic duties.

**Project summary:** Harohalli Industrial area is located in an area spanning around 3,600 acres. This is developed and supported by Karnataka Industrial and agricultural development Board to develop agricultural area into industrial area. This land is a centre of connectivity connecting Kanakapura Taluk on one side, Bangalore District on one side and Mysore highway on other side.

This place of greenery has attracted many industries to start here. Its easy connectivity to the capital of the state and other states through Mysore national highway offers best opportunity for any start up business. Keen on developing this area and thereby the people, the State government provides loans at lesser rate of interest. To further encourage start up businesses to have their base here ,Government provides tax holiday benefits (tax exemption ) for certain number of years. This has in turn encouraged companies there to involve in corporate social responsibility.
