Administration of the signed MoU

- This MoU shall be effective and will come into force from the day the two authorized signatories of both the parties formally sign the MoU document.
- The authorized signatories and/or the Coordinators of SFS College and MYLOGIC will

o Implement this MoU and all endeavours that derive from it.

 Develop and carry out joint plans for the implementation of the objectives of the MoU by having regular communications.

Additional activities proposed within the framework of the general terms of this Memorandum of
Understanding will be formally incorporated as an addendum to this MoU, provided the addendum's
agreed to and signed by both parties.

Termination / Amendment of MoU

- Both the parties will endeavour to resolve disputes arising between them in relation to this MoU by amicable means. In the event of any irreconcilable differences, the MoU may be terminated by mutual consent of the two parties.
- Either party may terminate this MoU by written notification signed by the appropriate official of the institution initiating the notice.
- A minimum of three months prior notification shall be sent to the other party prior to the effective date
 of termination.

Intellectual Property Rights

Intellectual Property developed by the joint efforts would be the joint property of the Parties and any financial benefits or otherwise arising out of it shall be shared proportionately by the parties ir consonance with the efforts / inputs given by them.

Jurisdiction

All disputes are to be settled within the jurisdiction of Bangalore courts, State of Karnataka.

Undertaking by SFS College and MYLOGIC

Both the parties undertake to work closely and cooperate in the implementation of this MoU. The authorized representatives, including the signatory and the coordinator related to this MoU acknowledge having read and understood the MoU and agree to be bound by its terms and conditions.

SPECIAL TERMS

- The program details sent by MYLOGIC Business Management School Pvt Ltd, will be shared with the students during the admission process/at the beginning of a new semester. Students are free to enroll in any program that interests them.
- Ensure the students are told clearly about the fees, taxes, duration of the course, internship, class timings etc., and fees once paid will not be refunded, even if the student cancels the admission in the College or discontinues from the programme offered by MYLOGIC Business Management School Pvt Ltd,.
