St Francis de Sales College came into existence in 2004 with the motto *Excellence Transformation and Efficiency*. It is a minority recognized institution permanently affiliated to Bangalore University with UG, PG (including MBA) and PG Diploma Programs. In the year 2018, the College obtained UO and U(b) recognition under the UGC Act of 1967. AICTE approval for MBA was obtained in 2020. The College was granted 'B' grade by the NAAC in 2021. The College is also an ISO certified Institution.

About St. Jerome's First Grade College

Purpose of the MOU

The purpose of this Memorandum of Understanding (MOU) is to formally create a mutually beneficial working relationship between St. Francis de Sales College and St. Jerome's First Grade College.

In particular, the MOU is intended to

- To support Academic exchange (Student/Faculty/Internship/etc) Program
- To jointly propose and engage in research or training programmes sponsored by funding agencies, and to invite each other's Faculty and Students to participate therein
- To jointly organize seminars, conferences, or workshops on topics of mutual interest and to invite each other's Faculty and Students to participate therein
- To create an Ecosystem for Innovation and Knowledge transfer
- To exchange information on research and educational programmes
- To exchange, on a reciprocal basis, Faculty and Students at Undergraduate and Post-Graduate levels for limited periods of time for the purpose of education and/or research.

Duration

This MoU is for a period of 3 years. It can be extended further by mutual consultation and agreement.

Co-ordinators

- St. Francis de Sales College: Mr. Drava Kumar K.S., Asst Prof., Department of Commerce will serve as the Coordinator. He will also sign as a witness in the MoU.



- St Jerome's First Grade Degree College. Ms.PRI MA will serve as the Coordinator. He/She will also sign as a Witness in the MoU
- The respective Coordinators of St Francis de Sales College and St Jerome's First Grade College shall be responsible for all the communication between the two institutions and the implementation of the proposed objectives of the MoU.

Administration of the signed MoU

- This MoU shall be effective and will come into force from the day the two authorized signatories of both the parties formally sign the MoU document.
- The authorized signatories and / or the Coordinators of St Francis de Sales College and St Jerome's First Grade College will
 - o Implement this MoU and all endeavours that derive from it.
 - o Develop and carry out joint plans for the implementation of the objectives of the MoU by having regular communications.
- Additional activities proposed within the framework of the general terms of this MoU will be formally incorporated as an addendum to this MoU, provided the addendum is agreed to and signed by both the parties.
- Both St Francis de Sales College and St Jerome's First Grade College shall inform, in writing, the respective communities of this MoU to draw benefits from it and to contribute towards its implementation in spirit and substance.

Termination / Amendment of MoU

- Both the parties will endeavour to resolve disputes arising between them in relation to this MoU by amicable means. If this not possible because of irreconcilable differences, then this MoU may be terminated by mutual consent of the two parties.
- Either party may terminate this MoU by written notification signed by the appropriate official of the institution initiating the notice.
- A minimum of three months prior notification must be sent to the other party prior to the effective date of termination. Any change to this time period, would be binding, only on mutual consent in writing.

Intellectual Property Rights

Intellectual Property developed by the joint efforts would be the joint property of the Parties and any financial benefits or otherwise arising out of it shall be shared proportionately by the parties in consonance with the efforts / inputs given by them.

Jurisdiction

All disputes are to be settled within the jurisdiction of Bangalore courts, State of Karnataka.
