### Details of ST PAULS COLLEGE, Bengaluru

With the vision inspired from Blessed James Alberione, ST PAULS COLLEGE, Bengaluru aims to nurture students; with special focus on media education, to become mature and responsible citizens by ensuring a conducive environment to pursue academic excellence and holistic growth. We are marching towards our vision of an inclusive, holistic education system aided by our mission ST PAULS COLLEGE, Bengaluru endeavours to identify the students potentials and talents in and to draw out the best in them by providing ample opportunities and facilitating genuine opinion formation in order to make them visionaries and professionals, and committed citizens of tomorrow.

## St. Francis de Sales College (SFS COLLEGE), Bangalore

St. Francis de Sales (SFS) College is manned by the Missionaries of St. Francis de Sales (MSFS) of South West India Province, who firmly believe that 'the education of the heart is the heart of education' hailed by its founder Fr. Peter Marie Mermier.

SFS College came into existence in 2004 with the motto: Excellence, Transformation and Efficiency. It is a minority recognized institution which is permanently affiliated to Bangalore University. The College was granted "A" grade by the NAAC in 2015. The Postgraduate Centre was added to the College in 2017. #### Purpose of MOU

The purpose of this Memorandum of Understanding (MOU) is to formally create a mutually beneficial working relationship between ST PAULS COLLEGE, Bengaluru and St. Francis de Sales College.

#### In particular, the MOU is intended to

- To support towards Academic exchange (Student/Faculty/internship/etc) Program
- To jointly propose and engage in research or training programmes sponsored by funding agencies, and to invite each other's faculty and students to participate therein
- To jointly organize seminars, conferences, or workshops on topics of mutual interest and to invite each other's faculty and students to participate therein
- To create an Ecosystem for innovation and knowledge transfer
- To exchange, on a reciprocal basis, Faculty and Students at Undergraduate and Post-Graduate levels for limited periods of time for the purpose of education and/or research.

#### Duration

This MoU is for a period of 3 years. It can be extended further by mutual consultation and agreement

#### Co-ordinators

- ST PAULS COLLEGE: Mr. Jenin Raj. S, Head, PG Dept of Journalism and Mass Communication will serve as Coordinator. He along with Rev. Fr. Dr. Thomas MJ, Principal, will sign as Witness in the MoU document.
- St. Francis de Sales College: Dr./Ms./Mr. Prof. Druva Kumar (MOU Co-ordinator) will serve as Coordinator.

The respective Coordinators of ST PAULS COLLEGE and St. Francis de Sales College shall be responsible for all the communication between the two institutions and the implementation of the proposed objectives of the MoU.

#### Administration of the signed MoU

- This MoU shall be effective and will come into force from the day the two authorized signatories
  of both the parties formally sign the MoU document.
- The authorized signatories and/or the Coordinators of ST PAULS COLLEGE Bengaluru and St. Francis de Sales College will
  - o Implement this MoU and all endeavours that derive from it.
  - develop and carry out joint plans for the implementation of the objectives of the MoU by having regular communications.
- Additional activities proposed within the framework of the general terms of this Memorandum of Understanding will be formally incorporated as an addendum to this MoU, provided the addendum is agreed to and signed by both the parties.
- Both ST PAULS COLLEGE Bengaluru and St. Francis de Sales College shall inform in writing the
  respective communities of this MoU to draw benefits from it and to contribute towards its
  implementation in spirit and substance.

#### Termination / Amendment of MoU

- Both the parties will endeavour to resolve disputes arising between them in relation to this MoU by
  amicable means. If this is not possible because of irreconcilable differences, then this MoU may be
  terminated by mutual consent of the two parties.
- Either party may terminate this MoU by written notification signed by the appropriate official of the institution initiating the notice.
- A minimum of three months prior notification must be sent to the other party prior to the effective date of termination.

#### Intellectual Property Rights

Intellectual Property developed by the joint efforts would be the joint property of the Parties and any financial benefits or otherwise arising out of it shall be shared proportionately by the parties in consonance with the efforts/inputs given by them.



#### Jurisdiction

All disputes are to be settled within the jurisdiction of Bangalore courts, State of Karnataka.
